Peshawar Development Authority (PDA), Government of Khyber Pakhtunkhwa, invites bids, through EPADS, on percentage above/ below on Engineer cost estimate, in accordance with Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KP-PPRA) Rules 2014 (amended from time to time) on **SINGLE STAGE SINGLE ENVELOPE PROCEDURE**. The bidder shall be registered with (i) e-Pak Acquisition and Disposal System (EPADS) (ii) Valid Pakistan Engineering Council (PEC) License for the year 2025-2026 in the required category, (iii) Valid Registration of Khyber Pakhtunkhwa Revenue Authority (KPPRA) (status shall be active) (iv) Valid Registration of Federal Board of Revenue (FBR) (NTN status shall be active), (v) Valid Enlistment with Provincial Enlistment Committee, Khyber Pakhtunkhwa/PDA for the current year



1. Sample Tender form, Bid Solicitation Documents (BSD) / Bidding Data / Bill of Quantity (BOQ) can be downloaded from the official website of EPADS (kp.eprocure.gov.pk), official website of KP-PPRA/PDA
2. The bidders shall upload all mandatory documents like PDA/ Provincial enlistment/renewal, PEC Registrations, NTN(Active), KPPRA (Active), Affidavit of never been blacklisted/ No litigation by the Government / Semi-Government or any Autonomous body, etc. on EPADS as per the required criteria.
3. The bidder shall only submit their original bid security/additional security (if applicable) and tender form fees, in separate envelopes, in the shape of call deposit receipt made in favour of Director General, PDA, in the office of the undersigned through registered post/courier before last date and time for bid submission.
4. The received Bids will be opened (downloaded from EPADS) in the presence of bidders/their representative (who may like to attend) in the office of the chairman procurement wing, PDA on the day & time mentioned above.
5. The bidders should submit their 2% bid security and additional bid security (if any) as per KPPRA rules and KPPRA Notification No. SRO (14)/Vol: 1-24/2021-22/6058-71 dated Peshawar, 10/05/2022.
6. Clarifications/queries, if any, shall be asked/communicated through EPADS or from the office of the undersigned within the office hours before last date and time for submission of bid



- 7. If the Bid becomes tie, it will be decided through open toss.
- 8. For work at Serial#3, the bidder must have successfully completed at least one similar project of supply and installation of children's play equipment or park furniture works having a cost not less than Rs. 5.0 million during the last five (05) years. Documentary evidence (completion certificate) must be uploaded on EPADS along with the bid.
- 9. Validity of Bids will be 90 days from opening of tender
- 10. Incomplete / conditional bids with cutting / overwriting / disfiguring shall be considered as "non-responsive".
- 11. All other terms and conditions shall remain intact as per guideline and rules framed by Provincial Government.
