NOTIFICATION.

The PDA Board of Authority in its 11th meeting held on 22/05/2024, under the Chairmanship of Honourable Chief Minister, Khyber Pakhtunkhwa / Chairman PDA Board, in Conference Room of Chief Minister House, approved the agenda item No.32 regarding the following amendment in PDA Auction Regulation 2021: -

AMENDMENT NO. 1

The Regulation 5 of the PDA Auction Regulation 2021 read as:

"(5) School/Educational plot (Private Sector): School/ Educational plots (private sector) will be auctioned on ownership basis."

To incorporate the proposed arrangement of giving such plots on lease/rental basis following text is proposed to replace the existing text:

- "(5) School/Educational plot (private sector): School/ Educational plots with building (private sector) will be auctioned.
 - a. On ownership basis
 - b. On lease basis for period of not less than 33 years (premium + monthly rent)
 - On rental basis (for period of 10 years to 15 years) with security advance of 3 years.
 - d. In PPP/JV mode on fee sharing basis"

AMENDMENT NO.2

Existing text of Clause-I(1) of the PDA Auction Regulation 2021 (amended 2021) reads as:
