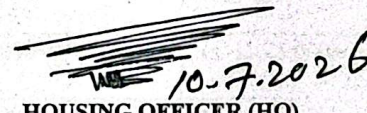

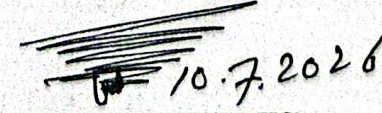

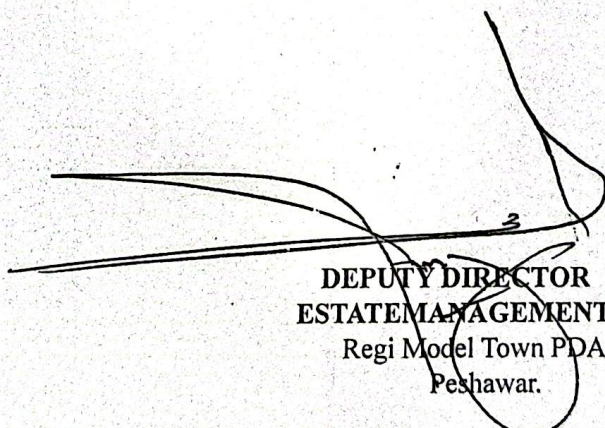

- iii. The Highest bidder will be required to deposit the amount equal to 35% of bid amount in the PDA account within 10-days of communication of approval of the bid. If the bidder fails to deposit the required 35% of bid amount within 10-days, the bid shall be cancelled and the call deposit shall stand forfeited in favor of the Authority.
- iv. The successful bidder /Firm shall deposit the balance 65%^h of the bid amount within a period of (2) months (60 days) of the issuance of offer/allotment letter. In case of non-payment of the 65% amount within 60 days the offer shall stand withdrawn with forfeiture of the deposited amount.
- v. The call deposit of the 3 highest bidders will be retained for 14 days. The rest of call deposits will be returned back at the end of auction proceedings.
